The application without cost of tender paper will be considered invalid and inevitably rejected.
- Application for Tender Paper should be submitted to the undersigned from **11:00 AM** to **1:00 PM** on dated **19-06-2015**, with valid VAT Clearance, Income Tax Clearance, Professional Tax Clearance certificates & Credential Certificate of Rs. 2 lacs from the Competent Authority in the form of Payment Certificate of single civil constructional work.
- Tender Paper will be issued to the qualified contractors on **23-06-2015** from **11:00PM to 03:00PM**.

4. The undersigned is not bound to issue tender paper to all the applicants.
5. Decision of the undersigned regarding the issuance of tender papers is final.
6. Tender papers will have to be submitted in person & it should be reached the undersigned from **23.06.2015 between 11.00 A.M. and 5.00P.M. and latest by 2.00 P.M. on 26.06.2015 positively.**
7. It will be opened on **26-06-2015.**, at **03:00 PM** in the office of the undersigned. The interested tenderers may remain present at the time of opening.
8. The successful contractor must complete the work within the stipulated period. No extension of time will be allowed except in special case. If any contractor fails to complete the work within the stipulated time, the work order issued in his favour will be cancelled without assigning any reason therefore. The undersigned will proceed to get the residual work completed by any other means including through other contractors. The excess expenditure, if any, due to such step would be recovered from the unpaid bill / security deposit of the agency. The Undersign may black list him & forfeit the earnest money deposited by him, in addition to the above stated measure.
9. 10% security money will be held by this office after completion of the work. The security money will be released after completion of 180 days, provided no complaint received against the work in this office.
10. No R / A bill will be entertained.
11. The rate should be quoted both in figure & as well as words. All rates are inclusive of all charges i.e. royalty, toll charges, carriage & all taxes etc.
12. No tender will be allowed with rate 04.99% above than the scheduled rate. In case of rate quoted less than 10% of the scheduled rate, Technical Analysis should be annexed with the tender paper.
13. Incomplete tender paper will be rejected summarily. The successful tenderer will have to execute a formal agreement on N. J. S. amounting to Rs. 10.00 within ten working days from the date of issuing of acceptance letter.
14. Current NOC from the office of the ARCS & Audit report for last financial year i.e. 2014-15 will have to be submitted for Engineers' co operatives & labour co-operative societies at the time of application. The tender forms are to be received & signed by either Chairman or Secretary of the said co-operative societies.
15. **2% earnest money in form of Demand Draft drawn in favour of the undersigned should be submitted by all the contractors excepting the Co-operative Societies only for the works reserved for the Co – Operative Societies.**
16. All the works should be done in accordance with the specification & schedule of works & as per direction of the Tendering Authority in addition to specifications of PWD schedule of woks. All materials supplied by the agency should be as per specification of PWD schedule of works.
17. Rejected materials should be removed from the site within 24 hours from the receiving of the undersigned or his authorized representative.
18. Before starting the work a written work programme has to be submitted to this office & the work site should be cleared by cutting jungle etc. & dressed, for which no extra payment will be made.
19. Acceptance of lowest rate is not obligatory & undersigned reserved the right to accept or reject any or all the tenders without assigning any reason thereof.
20. I.T., VAT, Royalty & other deductions as applicable as per Government norms will be deducted at source.
21. The Terms & Condition of this notice will be part of formal agreement & all the tenderers will have to abide by them.
22. Before submission of the tender, contractors must visit the work site to judge the local condition. No plea or complaint regarding the site condition will be entertained after submission of the tender paper.
23. All tools, plants & machineries required for the work are to be arranged by the agency.
24. The successful tenderer will have to be abide by the provision of the West Bengal Contract Labour Act 1972 & successive amendments thereof.
25. If the date of submission of tender paper is declared holiday, the tenders will be received on the next working day or any other subsequent date as fixed at the stipulated time.
26. Claim for idle labour from contractor will not be entertained under any circumstances. No claim will be entertained for increase of Railway freight & market price.
27. No rectification in the rate submitted will be entertained.
